#### REPORTS AND PROPOSED DELIVERANCES

#### CONGREGATIONAL BUSINESS

#### LEITH ST ANDREW'S AND ST DAVID'S BROOMHOUSE

The Clerk will report that in terms of Act VIII 2003 anent Vacancy Procedure, the Strategy Team, sitting as the Vacancy Procedure Committee for Leith St Andrew's had received a call signed by 97 members and 1 adherent in favour of Rev Rob Mackenzie, Minister of St David's Broomhouse.

## The Committee agreed to

- 1. sustain the Call to Mr Mackenzie
- 2. note receipt of a letter from Mr Mackenzie accepting the Call and confirming that he has used no undue influence in obtaining the Call.
- 3. note that Mr Mackenzie has signed the Basis of Reviewable Tenure.
- 4. release Mr Mackenzie from his charge of St David's Broomhouse
- 5. ask Presbytery to meet *in hunc effectum* for Mr Mackenzie's induction on Tuesday 12<sup>th</sup> February at 6.45pm for service at 7pm in Leith St Andrew's Parish Church.
- 6. instruct the Clerk to make arrangements for the service in consultation with the Moderator of Presbytery.
- 7. instruct the Clerk to appoint an Interim Moderator.
- 8. in terms of the Presbytery Plan grant the congregation of St David's Broomhouse permission to call a minister on a Basis of Reviewable Tenure.
- 9. refer the matter of negotiating the Basis of Reviewable Tenure to the Deployment of Resources Committee
- 10.instruct the Clerk to issue a Schedule A notice to both congregations informing them of this process and to circulate to the Presbytery by e-mail all in terms of Act VIII 2003 anent Vacancy Procedure.

## ST NICHOLAS SIGHTHILL

## 4. Sunday Parking

encourage congregations to make representation to their local councillor and Councillor Lesley Hinds, Convener of the Edinburgh City Council Transport and Environment Committee, relating to proposals to introduce Sunday parking controls as part of a revised transport strategy for the city, as and when such proposals are put forward for public consultation.

#### **Background**

The Edinburgh Council Transport Committee met on 15<sup>th</sup> January 2103 and looked proposals to a) extend their 2007-2012 transport strategy to 2013; and b) agree a new transport strategy for 2014-2019. With regards to the latter, the discussion included the following proposals:

 Extending 20mph speed limit zones - potentially to all residential and shopping streets;

- Extending 30mph speed limit zones potentially on all streets with any urban frontage (i.e. houses, shops or businesses) with the exception of dual carriageways like Calder Road;
- Introducing some degree of Sunday parking controls;
- Using net revenue from Sunday parking specifically to improve Sunday bus services;
- Investigating the possible introduction of a Low Emissions Zone; As an extension of parking controls on a Sunday will affect many congregations in the Presbytery, the Strategy Team, in collaboration with the Social and Community Interests Committee, encourages congregations to make appropriate representations to their Local Councillor and Lesley Hinds during the public consultation period. Details of the consultation are, as yet, not available, but congregations should access the Council's website for further information -

## **DEPLOYMENT OF RESOURCES**

On the Report of the Deployment of Resources Committee it will be moved that the Presbytery:

#### 1. St Cuthbert's

- a. approve the ordination of Suzie Stark; and
- **b.** approve the appointment of Mrs Stark to the unsalaried and part-time post (25 hours per week) of Assistant at St Cuthbert's for the duration of her part-time studies.

#### 2. Parish Boundaries

approve the changes to the parish boundaries of Balerno, Fairemilehead, Kaimes Lockhart Memorial and Tron Kirk Gilmerton and Moredun.

## St Cuthbert's - Background

Ms Stark was a Probationer at St Cuthbert's until November of last year and has successfully completed her probationary period. Having been only required by the Ministries Council to complete an ordinary degree, Ms Stark feels she may have inadvertently limited her potential for future study or research and now wishes to complete the BA (Hons) degree course for which she requires a further two 60 credit courses. Following completion of this in the autumn of 2013, she intends to embark upon a two year part-time post-graduate chaplaincy certificate; Ms Stark is a part-time volunteer chaplain at St Columba's Hospice. These additional qualifications should contribute to her overall formation for ministry

as well as preparing her for future work either within a healthcare chaplaincy situation or in the parish.

During the period of further part-time study, and in addition to her continued volunteer chaplain role, it would be of benefit for Ms Stark to continue in a pastoral and worship setting, exercising ministry alongside her further educational pursuit. The worship provision in the city centre involves a considerable and growing 'menu' of worship opportunities at St Cuthbert's and, set alongside the particular mission and pastoral challenges facing this congregation, Ms Stark's appointment to the St Cuthbert's Ministry Team would be of great assistance. In this unsalaried part-time post of 25 hours per week, Ms Stark's role would embrace worship, (including celebration of the sacraments), pastoral care and outreach, the latter within the wider Ministry Team of the Ecumenical Parish Grouping 'Edinburgh City Centre Churches TOGETHER'.

Ordination, which is supported by the Ministries Committee, is a requirement for sacramental ministry and would enable Ms Stark to undertake celebration of the sacraments in the worship context at St Cuthbert's. As an ordained person, she would also be able to minister more fully and effectively in her chaplaincy role at St Columba's, offering the sacrament in that context.

This appointment is outwith the Presbytery Plan and, although Ms Stark would be an ordained minister, looking to her commitment to further part-time study she would not be in the pool of ministers available for full-time parish posts until completion of her studies.

## **Parish Boundaries - Background**

Arising from the digitisation of all parish boundaries in Scotland a number of discrepancies have emerged affecting four parishes in the Presbytery of Edinburgh.

In the case of Balerno, the present boundary runs through the middle of Threipmuir Reservoir. The City and Lothian boundary is to the south and the Balerno Kirk Session are happy for their boundary to be so aligned.

Changes to Fairmilehead, Kaimes Lockhart Memorial, and Tron Kirk Gilmerton and Moredun are due to the change in the City boundary which now runs along the City Bypass. These are very minor changes and, along with the change to the Balerno boundary, brings the southern boundary of the Presbytery of Edinburgh in line with the northern boundary of the Presbytery of Lothian.

#### **PROPERTY COMMITEE**

On the report of the Property Committee it will be moved that the Presbytery

### **Inverleith St Serf's Parish Church**

- **1.** grant approval for the marketing of the site of the former Inverleith church, halls and manse; and the sale of any or part of the site can be arranged subject to the agreement of the Church of Scotland Legal Department and the Kirk Session of Inverleith St Serf's Parish Church.
- **2.** grant approval for the renewal of the seating in the sanctuary through the replacement of the existing 350 chairs at a cost of £42,036 plus VAT of £9,668 (£51,704). (the approval of The Artistic Matters Committee has been granted)

#### **WORLD MISSION**

On the report of the World Mission Committee it will be moved that the Presbytery

- 1. note the deputation visit of George and Margaret Shand (St Andrew's, Jerusalem) 21-30 April, and encourage partner churches to arrange events for them
- **2.** encourage congregations to make increasing use of Fairtrade products, and to pursue achieving Fairtrade status

## **Report**

Fairtrade Fortnight runs from Monday 25 February to Sunday 10 March. Fairtrade is about better prices, decent working conditions, local sustainability, and fair terms of trade for farmers and workers in the developing world. Results of the recent World Mission survey show that 34 out of the 68 churches that responded support Fairtrade, but only six have 'Fairtrade Church' status. To gain this status a church must

- Use Fairtrade tea and coffee after services and in all meetings for which you have responsibility.
- Move forward on using other Fairtrade products such as sugar, biscuits and fruit.
- Promote Fairtrade during Fairtrade Fortnight and during the year through events, worship and other activities whenever possible.

An example of promotion is the '90kg challenge'. Just Trading Scotland promote this initiative where churches and schools make a commitment to sell 90kg of fairly traded rice (RRP £2.99 per Kilo). Selling this is the amount of rice would enable a Malawian farmer to pay for a year's basic secondary education for one child. This challenge can be taken up via the Just Trading Scotland website -

#### **SOCIAL AND COMMUNITY INTERESTS**

On the report of the Social and Community Interests Committee it will be moved that the Presbytery

## 1. Palliative Care and the Liverpool Care Pathway

notes and registers interest in the Independent Inquiry to be led by Rabbi Lady Julia Neuberger into the Liverpool Care Pathway which follows mixed experiences of families.

The Liverpool Care Pathway is designed to ease a terminally-ill patient's last days by avoiding unnecessary treatment and offering palliative care, however "The name of the Liverpool Care Pathway, which has become tainted by allegations, may go" (Guardian, January 15<sup>th</sup>). The inquiry has been commissioned by Care Services Minister Norman Lamb.

#### 2. Welfare Reform

Invites congregations to consider sponsoring a meeting on Welfare and Benefits Changes, and commends two papers on this subject: the briefing "Welfare Reform" produced by the Ministries Council with the Church & Society Council and the information leaflet, entitled 'Welfare Reform – this will be the biggest change to benefits in modern times' from Faith in Community Scotland.

As well as introducing a cap on benefits Universal Credit (which will gradually replace income support, income-based jobseeker's allowance, income-related employment and support allowance, housing benefit, child tax credit and working tax credit) will be paid to one individual in the household, monthly, and will require on-line registration.

These changes by the UK Government are intended to incentivise work and reduce poverty amongst those on low incomes. Others claim that they will force 'one person in four' into poverty. Whatever the arguments, having an awareness that there are major changes taking place will enable ministers, elders and pastoral care teams to respond appropriately to the situation of

parishioners. Congregations might like to invite a speaker from their local Citizens Advice Bureau to address a gathering to promote a discussion on how to support those most affected.

#### 3. Public Entertainment Licenses

notes with interest further proposals by the City of Edinburgh Council concerning Public Entertainment Licences (PELs) following interim changes made in April 2012.

The proposals may help community groups and include: To make permanent the current interim measures which exempt certain 'free to enter events' from the need to obtain a PEL,\_provided the capacity of the venue is less than 500 and the organisers are a community group or similar.

To exempt any public entertainment event where the capacity of the venue is less than 250 and the organisers are a community, youth, political or religious group. This would apply even if an entrance fee is charged.

For any remaining events organised by community groups - introduce a revised fee structure, which would allow these groups to apply for a PEL for 12 months at approximately 50% discount.

#### 4. Mortonhall Crematorium Historic Practices

notes and registers interest in an Independent Inquiry into historic practices (prior to May 2011) at Mortonhall Crematorium to be chaired by Dame Elish Angiolini, former Lord Advocate.

The previous practice of not offering families the ashes of their babies and burying them in the Garden of Remembrance came to light in December 2012 following discussions with SANDS (Stillbirth and Neonatal Death Society). The Social and Community Interests Committee are considering plans for an event on funeral and bereavement care and the findings of this Inquiry could form part of that.

#### PRESBYTERY STAFFING FUND

On the report of the Presbytery Staffing Fund Committee it will be moved that the Presbytery

## 1. Corstorphine Craigsbank

grant £6000 from the Presbytery Staffing Fund towards the appointment of a Children and Family Worker at Corstorphine Craigsbank, the grant being for one year in the first instance but with a view to it being continued for a further two years upon on a successful review of the post

## Children and Family Ministry Post

The Kirk Session wishes to appoint a part time Children and Family Worker to further develop its ministry among families in the congregation and parish. The post would be for 20 hours per week for three years in the first instance.

## **Background**

The congregation is responsible for two church centres at Craigsbank and East Craigs both of which are fully utilised by church and community groups with over 30 organisations using the facilities. This includes a Boys Brigade Company (all sections), two Girl Guide companies (all sections), two Scout groups (all sections), two Play Groups, three Parent-Toddler groups, an After School Club, and two All-Age Sunday School Groups meeting each week. Alongside these organisations for children and young people are organisations and activities for adults and older people, plus chaplaincy involvement with East Craigs Primary School and with Craigmount High School (in collaboration with St Thomas' Episcopal Church and Barnton Baptist Church).

#### **Local Context:**

The Presbytery Plan identifies Craigsbank as one of the larger parishes in the city (population 8000+) and one which is rapidly growing. Typically of a suburban parish there are higher numbers of children, fewer students and young adult workers and more mature adults and elderly people than the average for the Presbytery.

The Kirk Session recognises the workload on current ministry in a large parish with two vibrant church centres, active organisations, and the associated pastoral and missionary demands and opportunities. It has identified an additional ministry focussing on children and families as our priority need to support the current

ministry and enable the congregation to extend and develop their work with children and families.

Three key points have been identified:

- **1.** personal visits to family homes of those who once had but have now lost contact with the congregation.
- **2.** focus on groups involving parents of children who are members of youth organisations but not members of church
- 3. development of social media for communication and mission.

## Main tasks of postholder

The post holder would assist with the Kirk Session's mission in the community through establishing contact and building relationships with individuals, families and organisations within the church, youth organisations using church halls, and in the wider community to assess needs and interests and identify pastoral patterns of care and support.

#### This would include:

- Building on existing good relationship with the local primary school and high school in partnership with the minister and local ecumenical church partners thus fulfilling Presbytery's recognition of our priorities among (i) Children and Families (ii) Community engagement and (iii) working collaboratively with neighbouring Churches.
- Developing worship and social events with children and families and creating new opportunities for engaging with the Gospel, such as exploring Messy Church model.
- Developing the use of Social Media as a means of communication including Facebook, Twitter and the development of 'Forums' as a means of sharing information and getting feedback, building on existing use of website and emails for communicating.

## **Funding**

The congregation are seeking support with funding this new post over the initial 3 year period. The estimated annual cost is £12,000 inclusive of statutory employer costs and expenses resulting in a salary of approximately £10,500. The worker will be directly employed by the congregation and it is anticipated that the technical aspects of payroll will be administered through the church's central offices.

The Kirk Session and the Congregational Board have agreed that it is realistic to commit the congregation to provide funding of £6,000 per annum over the three year period

#### **FINANCE**

On the report of the Finance Committee it will be moved that the Presbytery

- **1.** note that the contractual hours worked by the Presbytery Secretary were increased at the September meeting of Presbytery and agree the consequent increase in budgeted expenses of £4,076 per annum. (This notice to Presbytery is required under Standing Order 13 (c).)
- **2.** note that Presbytery has issued a letter to Ministers and Treasurers recommending that claims for Gift Aid are brought up to date by April  $5^{th}$  to avoid the loss of benefit under the new Gift Aid regulations which come into force in April 2013.

## **Gift Aid Small Donations Scheme**

HMRC will be introducing the Gift Aid Small Donations Scheme (GASDS) in April 2013. This is a **new** scheme that will enable charities and community amateur sports clubs (CASCs) to claim Gift Aid 'style' payments on **cash donations** where it is difficult to get a Gift Aid declaration eg: bucket collections or church plate donations. Charities and CASCs will be able to claim this 'top-up payment' on individual cash donations of up to £20 each, normally on up to a total maximum of £5,000 of small donations in one tax year. This means that most qualifying charities and CASCs will be able to claim up to £1,250 (25% of £5,000) of Gift Aid Small Donations each year.

This would be **in addition** to their normal Gift Aid repayment claims.

The conditions of GASDS is that the charity or CASC:

- has been established as a charity or CASC for the last two tax years
- has claimed Gift Aid in at least two of the last four tax years.
- has not had a period of two or more years of not claiming
   Gift Aid in the last four tax years.
- has claimed Gift Aid on donations of at least 10% of the amount of the small donations on which top-up payments are claimed in the same tax year.

 has not incurred a penalty under Gift Aid or GASDS in the tax year in which top-up payments are claimed (however Gift Aid claims in this year will still count toward future GASDS eligibility tests).

## There are some additional points to note:

If a charity runs charitable activities in a community building, the maximum limit of £5,000 may be increased by up to a further £5,000 for small donations collected in each community building. CASCs are unable to apply for this.

Charities and CASCs that are  $\underline{connected *}$  with one another will share between them the main £5,000 limit on which small donations may be claimed. However, these donations may be "pooled" to allow one member of the connected charities to claim the top-up payment on the combined donations.

Claims on donations received under the community buildings rules are not affected by connected charities rules.

\*Charities are defined as <u>connected</u> if they have purposes and activities that are the same, or substantially similar and they are controlled by the same person, or connected persons, or where one charity or CASC has control over another charity or CASC.

#### **RESOURCING MISSION**

On the report of the Finance Committee it will be moved that the Presbytery:

#### Wester Coates Fund

This fund was set up by the General Assembly of 1973 under Act XVII in the following terms:

To pay and make over the whole net proceeds of sale to the General Treasurer of the Church, the capital (to be known as "Wester Coates Fund") to be held by him and the income thereof to be applied by him at the direction of the Presbytery of Edinburgh from time to time for the financial support of Ministerial Assistance (including Deaconesses).

At the time Ministerial Assistance was primarily offered through the office of Deacon. However over recent years congregations have developed a variety of roles which could be classified as Ministerial Assistance.

In light of these developments Resourcing Mission consider it appropriate to now open this fund to all congregations who have

employed additional ministerial staff. This would include both congregations where staff positions are funded locally or through central funding.

Please note there is no set amount awarded each year. The General Treasurer passes the interest to the Presbytery which is then split amongst all eligible applicants. Congregations making application on behalf of a full time post will receive a full share with part times posts being awarded on a proportional basis.

To make application please return the attached form to the Presbytery Office no later than 31st March 2013 after which Resourcing Mission will consider all applications at their next meeting. Any monies awarded will be passed on after they have been received from the General Treasurer

From 30-31<sup>st</sup> January I attended the Ministries Council's Presbytery Conference as one of four representatives from Edinburgh.

#### Courses

From 21-23 January I attended the Church of England's National Archdeacons' Conference. On this occasion I was accompanied by the Presbytery Clerk of Glasgow. The main themes were –

- mission, organisation and the management of change,
- mission shaped church buildings and models for the future
- the future of archdeacons' ministry in a mission context.

I hope to share the insights and resources gained with the appropriate committees of Presbytery.

BASIS OF REVIEWABLE TENURE EDINBURGH: PILRIG ST PAUL'S

The minister shall be free to seek to demit or to be translated as in the ordinary case of any minister inducted to a charge, provided that, if this reviewable tenure is his or her first charge, the Presbytery hereby agree that these conditions constitute exceptional circumstances in terms of Section 4 of Act VIII 2003, and will accordingly issue the necessary Certificate if he or she seeks to be translated within five years.

Bursaries were awarded to 17 of 18 applicants, each full-time student receiving £1500 and part-timers £1000. The Committee noted with concern the financial plight of candidates in training for ministry, many now borrowing substantial sums of money each year to finance their programme of study. The general absence of congregational support was also apparent. The Principal of New College agreed to address this matter with fresh fund-raising efforts and the preparation of an article for Life & Work.
